Minutes of 92nd Annual General Meeting of Durban Golf Club held on 16th May 2021 at 07:00 at the Clubhouse, Papwa Sewgolum Golf Course and via Zoom.

Attendance:

As per attendance register.

Welcome:

The President, Sanil Rampersad, confirmed the quorum and declared the meeting open. He welcomed the membership and expressed his appreciation for their presence. He apologised for the delay in hosting the AGM, which was the result of the knock on effects from the Covid pandemic.

Notice of Meeting:

The notice was circulated to the entire membership and taken as read.

The following proxies were received:

- Mano Chetty appointing Ronnie Chetty
- Bob Bahadur appointing Sanil Rampersad

Confirmation of minutes:

The minutes were moved for adoption by Robert Manjoo and seconded by Baboo Khan. There were no amendments to the minutes.

Committee Report:

The report was circulated to the membership and posted on the website therefore, it was taken as read. The report was moved for adoption by Rajen Reddy and seconded by Babs Govender.

Treasurer's Report:

The Audited Financial statement by Logie Govender and Co. was posted on our website. Pradip Popat, the Treasurer, presented a summary of the report.

He reported that the Club received a distribution of R86 295.00 from the DGC Trust for the 2020 year. The surplus for the year was R61 981.00 and thus the Club is in a healthy and profitable position. The Beneficiary Account is currently at R490 914.00, which is the accumulated income from DGC Trust (the Club being the sole beneficiary of DGC Trust). These funds have now been received by the Club and will be invested.

Robert Manjoo reported that there are intentions to purchase the Papwa Sewgolum golf course from municipality sometime in the future.

Babs Govender asked the Committee to be cognisant that the upcoming centenary celebration needs to be included in the financial forecasting.

AC Khan raised a query on page 3 of the Audited Financials (Other information), whereby the date reads 31 December 2019. Pradip Popat confirmed this was an error and that the date should read 31 December 2020. This will be corrected by the Auditor.

There were no further queries pertaining to the financials.

The acceptance of the report was moved by Robert Manjoo and seconded by Baboo Khan.

Amendments to the Constitution:

There were no amendments to the Constitution.

Election of Office Bearers:

There was one nomination for President, Sanil Rampersad. Proposed by Naren Surjuprosad and seconded by Sathi Naicker. Sanil Rampersad accepted and was declared the President for the current year.

The President, Sanil Rampersad, was requested to choose his Committee, and they are:

The Committee was accepted and moved by Robert Manjoo and seconded by Bridge Singh.

Honorary Life Membership:

There were no applications for Honorary Life Membership.

Annual Subscription:

The DGC Committee proposed a 0% increase in the annual subscription for 2022. This was as a result of extensive discussions and due to the following reasons:

- Distributions recently received from DGC Trust would subsidise any shortfall.
- · The Club being in a healthy and profitable position.
- · Challenging financial climate as a result of the Covid pandemic.

The 0% increase was unanimously approved by the house.

Rajen Reddy queried membership numbers post Covid. Sanil Rampersad reported that the membership has dropped for a variety of reasons, ie, the financial impact of Covid and competition from other clubs, especially virtual clubs who are considerably cheaper. He also advised that the Committee is embarking on gaining more exposure by advertising the Club. Sagie Govender suggested reducing the annual subscription, however this can now only be considered for 2023.

Disciplinary Committee:

Babs Govender had advised the Committee that he would be unable to continue serving on the Disciplinary Committee. Sanil Rampersad requested the house to propose the names of suitable candidates. Amar Ramlochan proposed Enver Mall and AC Khan proposed Robert Manjoo. Robert Manjoo declined in favour of Enver Mall. The house approved the appointment of Enver Mall. Thus the committee is as follows:

Election of TWO (correction from Notice of AGM) Trustees:

Two Trustees (Robert Manjoo and Dr Rajruthnam) terms have expired and they did not wish to be re-elected.

The DGC Committee had received two nomination forms - Roshan Maharaj (proposed by Sanil Rampersad) and Amar Singh (proposed by Sanil Rampersad).

Both nominees had accepted their nominations. There were no objections from the house, therefore both were approved – moved by Sagie Govender and seconded by Furrhadh Jamal.

Durban Golf Club Golf Development NPC:

Robert Manjoo reported the following:

- MANCO has invested in machinery and equipment and has thus been able to keep its
 expenses low due to fewer repairs.
- · The Committee's finances are also in a healthy position.
- He advised that there was a vacancy on MANCO as he was the representative from DGC
 Trust (from which he has resigned). Ronnie Chetty advised that he has been elected onto the
 MANCO Committee. It was unclear if there was still a vacancy therefore Furrhadh Jamal
 suggested the house proceed with a nomination anyway and it can be confirmed at the next
 MANCO meeting. Pradip Popat nominated Robert Manjoo, who accepted.
- AC Khan requested an update on the cafeteria negotiations. Robert Manjoo reported that
 there had not been much progress as Council is "stagnant" due to challenges within the
 organisation. AC Khan requested that the last communication with Council be shared so that
 anyone, with permission from DGC Committee, can assist where possible. Sanil Rampersad
 advised that he will request this from Aslam Peer and share with him.

Durban Golf Club TRUST:

Baboo Khan reported the following:

The meeting terminated at 07:45.

- · The Trust only had one meeting since the last AGM.
- · The only issues were the Trustees expiration terms.
- Outstanding distributions have been paid over to the Beneficiary.
- Pradip Popat advised that the DGC Trust has applied for NPO status in order to take advantage of the tax free status.

Sanil Rampersad expressed his thanks and appreciation to all for attending as well as to Deena, Dhanashan and the Bar and Halfway staff. He urged the membership to provide input to the Committee on any suggestions, proposals, problems, etc

Robert Manjoo, on behalf of the membership, expressed his thanks to the President and his Committee for their excellent work.
